## Melrose Board of Health Rules and Regulations Concerning Minimum Sanitation and Safety Standards for Recreational Camps for Children

I. Authority

These regulations are promulgated under the authority granted to the Board of Health under Massachusetts General Law 111, section 31.

II. Minimum Standards and Administration

105 CMR 430.000 Minimum Sanitation and Safety Standards for Recreational Camps for Children (State Sanitary Code, Chapter IV) is hereby adopted in its entirety in its current form.

105 CMR 430.751 Failure to Comply with Order of the Board of Health

- (A) Any person who fails to comply with any order issued pursuant to 105 CMR 430.000 shall upon conviction be fined not less than \$10 nor more than \$100. Each day's failure to comply with an order shall constitute a separate violation.
- (B) Any person who fails to comply with any order issued pursuant to 105 CMR 430.000 and is issued a ticket pursuant to Revised Ordinance of the City of Melrose Section 1-21shall be issued a ticket in the amount as noted in Section 1-21. Each violation of each section of 105 CMR 430.000 shall constitute a separate violation. Each day's failure to comply with an order shall constitute a separate violation.
- 105 CMR 430.752 Failure to Comply with Provision of 105 CMR 430.000
- (A) Any person who shall violate any provision of 105 CMR 430.000 shall upon conviction be fined not less than \$10 nor more than \$100.
- (B) Any person who shall violate any provision of 105 CMR 430.000 and is issued a ticket pursuant to Revised Ordinance of the City of Melrose Section 1-21 shall be issued a ticket in the amount as noted in Section 1-21. Each violation of each section of 105 CMR 430.000 shall constitute a separate violation. Each day's failure to comply with an order shall constitute a separate violation.
- III. Severability

If any paragraph or provision of this regulation is found to be illegal or against public policy or unconstitutional, it shall not affect the legality of any remaining paragraphs or provisions being in force.

## IV. Effective date

These regulations shall be effective as of June 1, 2019
