



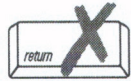

The project will include installing a granite stone staircase that is 36 inches wide and will be approximately 10 feet in height from top to bottom.

The project will also include the addition of two 4 foot high retaining walls, supporting the staircase, one terraced over 18 feet and the other 10 feet in length. The surrounding area will be covered with fill and covered with hardwood mulch to blend and extend to the landscaping currently in place.
