2021-2022 Application for Senior Citizen Low Income (50% or 100%) Trash Discount

The City of Melrose Revised Ordinances (January 2016 Chapter 198-3 section 3) provides for a discount on the quarterly trash fee for certain qualifying property owners. Such discount will be granted upon application by Senior Citizen (65 years or older) who occupy their properties and meet certain income guidelines.

To be eligible for the 50% or 100% discount on trash charge you must meet the following criteria:

- You must be 65 years of age or older on the day you apply
- Occupy the property as your principal place of residence
